SILC hosts Public Forums

The State Independent Living Council is in the midst of holding public forums to gather input for the 2011-2013 State Plan for Independent Living (SPIL).

As part of the SILC's federal mandate, the Council listens to public testimony about issues that affect the lives of persons with disabilities in Washington and incorporates these into the SPIL.

For the [2008-2010 SPIL](#), goals and objectives centered around the following topics:

- Housing
 - Transportation
 - Transition
 - Deinstitutionalization
 - Emergency Preparedness
 - Assistive Technology
 - Marketing, Outreach and Education to underserved and unserved minority, ethnic and disability groups, and
 - Expansion of CIL network in the state
- The next SPIL (2011-2013) will

likely cover many of the aforementioned topics, but are open to new ideas. The SILC encourages you to attend public forums to voice your opinion on what should be included in the SPIL.

Centers for Independent Living Receive "Stimulus" funding

As part of the historical American Recovery and Reinvestment Act (ARRA) signed into law by President Obama, the five Washington Centers for Independent Living recently received their notification of ARRA Part C funding.

The five CILs will receive \$269,422 each while the Redmond branch of the Alliance for People with Disabilities will receive \$202,067.

The funding will be used over a two-year period and will be used for things such as:

- infrastructure upgrades
- hiring and training benefits planners
- staff and board training and development, and
- marketing and outreach, services.

In addition to the Part C ARRA funding (those funds that come directly from RSA to the CILs.), each of the

CILs received Part B ARRA funding through a contract with the Division of Vocational Rehabilitation. This contract period runs from July 2009 and covers such activities as employee hires (Benefits Planners and Roads to Community Living Advocate) and equipment upgrades.

SILC Changes

The SILC itself has been remarkably stable in terms of its membership. The only change in membership was that Lynnae Ruttledge left WA DVR for RSA (see below).

Andrès Aguirre, the interim director of DVR, took over as the ex-officio member of the SILC.

A new slate of officers was elected at the November meeting. Romel Mackelprang (Spokane) was re-elected as the Council Chair. Jana Finkbonner (Bellingham) was elected as the

Vice Chair and Sandra Carr (Spokane) was elected as member-at-large. All of them will serve their terms until the Fall 2010 Meeting.

Lynnae Ruttledge goes to the Other "Washington"

Lynnae Ruttledge, former director of the state Division of Vocational Rehabilitation and SILC member, moved to Washington DC to become the Commissioner of Rehabilitation Services Administration (RSA).

Ruttledge was nominated by President Obama last fall, confirmed by the U.S. Senate on December 24th, and officially appointed on December 30. After that bit of a whirlwind, she left our WA and arrived in DC to begin work on January 4th.

She lives in the Capitol Hill area of DC and is often seen walking to work in her trademark orange jacket.

RSA is responsible for: basic state and formula grant programs in the following areas:

- independent living centers,
- service projects,
- rehabilitation training discretionary grant programs,
- Randolph-Sheppard

- vending facilities and Helen Keller National Center programs.

Since arriving in DC, Ruttledge and longtime colleagues and partners have reached out to her. She has already had several meetings with the National Council on Independent Living, the National Rehabilitation Association, and the Council of State Administrators for Vocational Rehabilitation.

The SILC consists of an eleven-person governor-appointed board, an executive director and a part-time executive assistant. The SILC is presently housed in the state's Division of Vocational Rehabilitation Office in Lacey. Most of the individuals on the Council are citizens with disabilities.

As laid out in section 705 of the Rehabilitation Act, as amended, the duties of the SILC are to:

- (1) jointly develop and sign (in conjunction with the designated State unit) the State plan required in section 704;
- (2) monitor, review, and evaluate the implementation of the State plan;
- (3) coordinate activities with the State Rehabilitation Council established under section 105, if the State has such a Council, or the commission described in section 101(a)(21)(A), if the State has such a commission, and councils that address the needs of specific disability populations and issues under other Federal law;
- (4) ensure that all regularly scheduled meetings of the Statewide Independent Living Council are open to the public and sufficient advance notice is provided; and
- (5) submit to the Commissioner such periodic reports as the Commissioner may reasonably request, and keep such records, and afford such access to such records, as the Commissioner finds necessary to verify such reports.
